

RECESS
Afternoon Session

The Senate reconvened at 1:30 p.m., pursuant to recess, President Murphy presiding.

Roll call showed all members present except Senators Brassey, McCann and Yarbrough, absent and excused.

Prior to recess the Senate was at the Thirteenth Order of Business, Third Reading of Bills.

H 512 was read the third time at length, section by section, and placed before the Senate for final consideration, the question being, "Shall the bill pass?"
